

KOHLER® Stainless Steel Sinks Lifetime Limited Warranty

Kohler Co. warrants its stainless steel sinks manufactured after October 24, 2012, to be free of defects in material and workmanship during normal residential usage for as long as the original consumer purchaser owns their home. This warranty applies only to KOHLER products purchased and installed in North America, Central America, the Caribbean and South America, excluding Brazil (“Americas”). Because Kohler Co. cannot control the quality of products sold by unauthorized sellers, this warranty applies only to products purchased from Kohler Co. or a Kohler Co. authorized seller, unless otherwise prohibited by law. Kohler Co. reserves the right to reject warranty claims for products purchased from unauthorized sellers, including unauthorized internet sites. This warranty is limited to the original, end-user purchaser.

Kohler Co. will, at its election, repair or replace a defective product that is covered by this warranty where Kohler Co. inspection discloses any such defects occurring in normal usage.* Gloss reduction, scratching, staining and acid or alkaline etching of the finish over time due to use, cleaning practices or water or atmospheric conditions, are not manufacturing defects but are indicative of normal wear and tear. Damage caused by improper installation, alteration to the product, accident, negligence misuse, or abuse is not covered by this warranty. Improper care and cleaning will void the warranty.** Proof of purchase (original sales receipt) must be provided to Kohler Co. with all warranty claims. Kohler Co. is not responsible for removal, installation, labor charges, or other incidental or consequential costs. In no event shall the liability of Kohler Co. exceed the purchase price of the product.

If this product is used commercially or used outside of the Americas, Kohler Co. warrants the product to be free from defects in material and workmanship for one (1) year from the date of purchase (or, for purchases in California, the date of delivery if later than the date of purchase), with all other terms of this warranty applying except duration.
