**In order to qualify for reimbursement, sales to consumers must comply with JennAir Brand's Unilateral Minimum Resale Pricing Policy (UMRP). In order to qualify for reimbursement, sales to Authorized Building Professionals must have a JennAir Premier Builder Number entered when submitting claims, show Builder name and Premier Builder Number on invoice and comply with the posted Builder UMRP.



CLAIMS

Program eligibility is based on date of sale. **All program claims should be made as soon as the product is sold.** Claims must be submitted on the Whirlpool HUB by the last day of the second month following the sale. The sooner the claim is entered, the sooner the reimbursement is processed.

Follow the simple three-step claim process on the Whirlpool HUB under Submit Claim.

STEP 1: ENTER INVOICE INFORMATION

If the sale was made to an authorized JennAir Premier Builder make sure to enter the Premier Builder Number. The number must be present on the invoice. Builder name must appear on the invoice. Make sure to enter your Claim Reference Number when submitting for easy tracking. It will appear on the credit memo and you can search for it on the Payments tab (see Figure A and B).

STEP 2: ENTER PRODUCT INFORMATION

STEP 3: UPLOAD OR FAX SUPPORTING CLAIM DOCUMENTATION

Customer invoices or other appropriate supporting documentation must accompany all claims. Invoices must clearly indicate the credit was given to the consumer.

AUDITS

All claims are audited. Invoices should be provided at the time claims are submitted for the quickest turnaround.

PAYMENTS

Claim to payment turnaround is between 7 and 10 days. Payments for approved claims are issued twice weekly by credit memo to Trade Customers' Whirlpool Corporation account.
